Despite efforts to reduce tax competition between states, taxation will remain a decisive argument, but other factors should not be underestimated either. It is up to all of us to be agile and to demonstrate an impeccable reception and follow-up capacity to convince prospects and carry out their projects. We are thinking in particular of the importance of rapid administrative processing of authorization files, rapid access to infrastructure, availability of skilled labor, last but not least, competitiveness and the quantity of energy supplies.

In addition to developments in the reorganization of working time - most likely a missed opportunity - and major investment projects and tax evolutions, 2016 was marked by the Rifkin process in which we are actively involved for our member companies.

Digitization is a major challenge for our members: the third industrial revolution, reflections on the work of tomorrow, technological breakthroughs starting to transform entire sectors of activity or the political or legislative projects on circulation and data protection testify to the fact that digitization is at the very heart of all economic problems. For our industries there are real advantages and FEDIL wants to continue to accompany them in this direction. To this end, the creation of the D4I-Digital for Industry initiative, now being carried out jointly with the Ministry of the Economy, is an important step towards a favorable future for industry.

That is why we decided to place the second half of 2017 - while preparing our centenary in 2018 - for actions that present all our sectors.
